e⁵ MicroC-Admix is a last generation dispersant admixture and open time regulator for the preparation of micro pastes.

PRINCIPAL APPLICATIONS

e⁵ MicroC-Admix can be used for:

Stabilization of micro pastes for injection.

DIRECTIONS FOR USE

Tests prior to its use are recommended to determine volume of mix water to form the micro paste (microcement+water) with the required consistency for the established application. To obtain better results of the micropaste we recomend using a water to microcement ratio between 0.4 and 0.8; to improve stability and adjust the open time of the micro paste. It is necessary to add our plasticizer e⁵ MicroC-Admix at a dosage of 4 to 10 mlLkg of microcement.

For its industrial application add the required volume of water, then add e⁵ MicroC-Admix and allow mixing during 3 minutes. Finally, add the established cuantity of admixture e⁵ MicroC-Admix and mix during 2 more minutes until achieving the desired consistency.

Preferentially use a high efficiency colloidal mixer to obtain better results. It is desirable to use a colloidal mixer achieving a minimum speed of 1500 rpm.

CAUTIONS

- Previous tests are recommended to adjust open workability time.
- If extending workability time of the micro paste is requiered, adjust the dosage of e⁵ MicroC-Admix. It is important not to exceed this admixture's recommended dosages as an excess can result in set delays. At a higher dosage, a higher open time.
- Always keep the product in its original container away from possible contaminating agents. Do not damage containers holding the product. Consult (MSDS) before handling the product.


